

Ordinance 2021-4

AN ORDINANCE ESTABLISHING BULK WATER RATES & CHARGES FOR THE TOWN OF CLOVERDALE, WATER UTILITY

WHEREAS, the Town of Cloverdale, Indiana (the Town) owns and operates a municipal water utility for the purposes of selling treated water; and

WHEREAS, the Cloverdale Town Code does not indicate a rate for bulk water; and

WHEREAS, the Town seeks to recover costs associated with the construction of the bulk water facility as well as credit card processing fees; and

WHEREAS, after a review of current Cloverdale residential rates, as well as comparative market rates; and

WHEREAS, the rates adopted herein are non-discriminatory, reasonable and just; and

Now, THEREFORE, BE IT ORDAINED by the Town Council of the Town of Cloverdale, Indiana, as follows:

- 1. Section 51.01 (A) (2) The following language shall be added to the "Water Utility Schedule of Water Rates and Charges".

Bulk Water \$.02 per gallon

- 2. All schedules of rates and charges in conflict herewith are hereby superseded.

Passed by the Town Council of the Town of Cloverdale, Indiana, this 11th of November, 2021, by a vote of 5 ayes and 0 nays.



WAIVER OF SECOND READING


On motion duly made and seconded, the second reading of the foregoing ordinance was unanimously waived, and the ordinance shall be deemed effective immediately upon passage.
