

Ordinance 2021-6

AN ORDINANCE ESTABLISHING THE PURCHASE AMOUNT FOR A WASTEWATER BACKFLOW FLAPPER.

WHEREAS, the Town of Cloverdale, Indiana (the Town) owns and operates a municipal wastewater utility for the purposes of treating waste; and

WHEREAS the Town currently sells backflow flappers to customers for an amount less than the town purchases them.

WHEREAS, the Town seeks to ensure good financial stewardship of the wastewater utility.

WHEREAS, the fee adopted herein are non-discriminatory, reasonable and just; and

Now, THEREFORE, BE IT ORDAINED by the Town Council of the Town of Cloverdale, Indiana, as follows:


1. Section 52.042 (F) Line 3 shall be amended to read:


This shall be purchased from the town at a cost of \$150.00 and a sewer permit fee of \$100.


2. All schedules of rates and charges in conflict herewith are hereby superseded.


Passed by the Town Council of the Town of Cloverdale, Indiana, this 16th of November, 2021, by a vote of 5 ayes and 0 nays.







WAIVER OF SECOND READING


On motion duly made and seconded, the second reading of the foregoing ordinance was unanimously waived, and the ordinance shall be deemed effective immediately upon passage.
